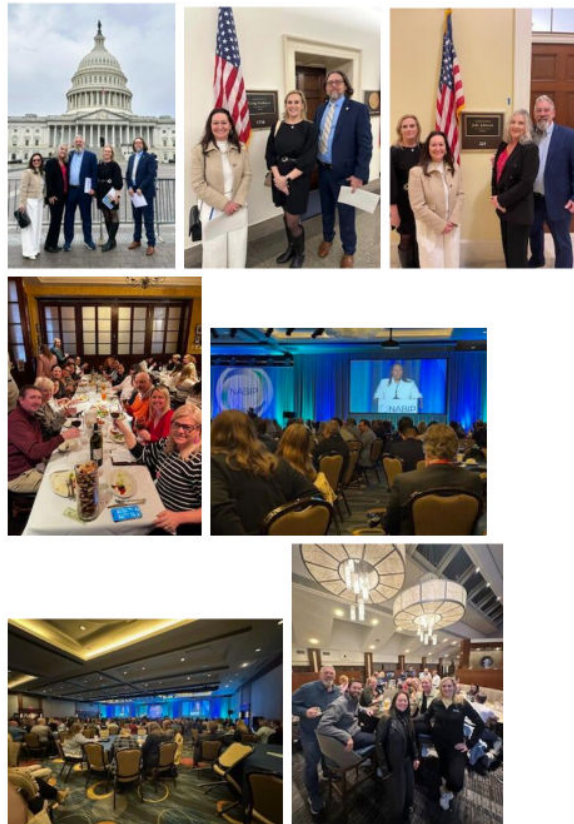


February 2025 - Capitol Conference, Washington DC

NABIP Fort Worth, a proud participant at the NABIP Capitol Conference in Washington, D.C.!

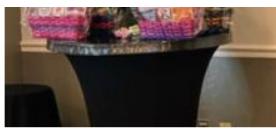
This annual event brings together industry leaders and advocates from across the country to engage with legislators on key healthcare and benefits issues. Our chapter is committed to representing the interests of our
